EFERT: Earnings clocked in at PKR 1.24 /share for 1QCY17, down by 22%YoY

- Engro Fertilizer Company Ltd. (EFERT) announced its financial result for 1QCY17 with earnings clocking at PKR 1.66bn (EPS PKR 1.24), down by 22%YoY as compared to PKR 2.12bn (EPS PKR 1.59) in the same period last year.
- During 1QCY17, net sales decrease by 15%YoY to PKR 10.06bn as compared to PKR 11.87bn reported in same period last year, on the back of low retention prices of urea and low DAP offtake.
- On quarterly basis, gross margins improved to 34.7% from 20% in 4QCY16 on the back of lower DAP offtake (contribute lower margins) and high reliance on new plant.
- Company's selling and distribution expenses augmented by +51%YoY to PKR 1.3bn in 1QCY17 as compared to PKR 0.85bn in the corresponding period last year on the account of export sales.
- Finance cost declined by 9%YoY to PKR 685mn as compared to 750mn in the corresponding period last year.

Recommendation

We maintain "BUY" call on EFERT with our Dec-17 target price of PKR 86/share, offering +37% upside from its last closing. The company is currently trading at a CY17E P/E of 7.8x and dividend yield of 10.3%.
