### **Bank Alfalah Limited (BAFL)**

Earnings: Bank Alfalah Limited (BAFL) announced its financial result for the third quarter of the year 2025. As per the financial result, the Bank reported unconsolidated earnings of PKR 6.2bn (PKR 3.91/share) during 3QCY25 compared to PKR 13.0bn (PKR 8.3/share) last year, posting a decline of -53%y/y/-25%q/q. The earnings for 9MCY25 has been recorded at PKR 21.4bn (PKR: 13.6/share), down by -36%y/y, as compared to PKR 33.5bn (PKR: 21.3/share) recorded in the same period of last year.

Dividend/Payout: The Company announced a cash dividend of PKR 2.5/share along with the result taking the cumulative dividends for 9MCY25 to PKR 7.5/share.

Operating Performance: During the 3QCY25 period under review, the Bank reported net-interest income of PKR 34.0bn (marginally down by -1%y/y) and non-interest income of PKR 11.0bn declining by -15%y/y. As a result, the bank's total revenue clocked in at PKR 45.1bn (down by -5%y/y). Moreover, BAFL recorded operating expenses of PKR 30.6bn (up by +44%y/y), with the bank's cost/income ratio increasing to 68% during 3QCY25 as compared to 45% in the same period last year. The bank booked a provision charge of PKR 1.1bn during 3QCY25 compared to a provision charge of PKR 0.4bn in 3QCY24. The tax charge for the quarter came at PKR 7.2bn (effective tax rate of 54% as compared to 49% in 3QCY24).
