### **Cherat Cement Company Limited**

**Earnings:** Cherat Cement Company Limited (CHCC) reported its 3QFY22, financial results. As per the unconsolidated financials, the company reported profit of PKR 1,065mn or PKR 5.5/share compared to last year profits of PKR 1,094mn or PKR 5.6/share, down by 3%y similarly on a quarterly basis earnings is down by 10%q.

**Dividends/Payouts:** The Company did not announce any dividend.

**Operating performance:** The Company recorded net sales of PKR 7,803mn up by 14%y, on quarterly basis it reported an increase of 2%q. Gross margins during the period clocked in at 27% compared to 30% last year same period down by 4%. As a result company's EBIT decreased to PKR 1,780mn down by 2%y (-8%q). Financing cost decreased to PKR 305mn down by 5%y, while effective tax charge clocked in at 28%.
